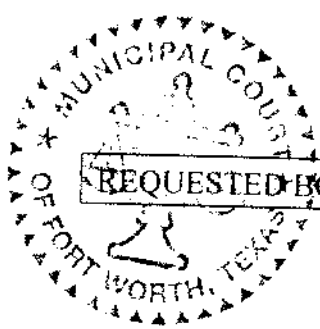

BEFORE ME, the undersigned authority, on this day personally appeared the undersigned affiant, who after being duly sworn on oath deposes and says; My name is **DETECTIVE M.D. Green, I.D. 2934, FORT WORTH POLICE DEPARTMENT**, and I have good reason to believe and do believe that on or about the 7th day of February 2012, in Tarrant County, Texas, Kimberly Smith, a white female, DOB 11/17/1969,

THEN AND THERE INTENTIONALLY OR KNOWINGLY BY ACT (OR OMISSION), ENGAGE IN CONDUCT, TO-WIT: placed a rag in the mouth of Jessica Smith in an attempt to smother her and then threatened to kill Jessica and herself with a knife. AND SAID CONDUCT PLACED Jessica Smith, A CHILD YOUNGER THAN 15 YEARS, IN IMMINENT DANGER OF DEATH, BODILY INJURY, OR PHYSICAL AND MENTAL IMPAIRMENT.

My belief is based upon the following facts and information:

- That on February 6th, 2012, Jessica Smith who is 11 years old (DOB 12/03/2000) was arguing with her mother Kimberly Smith at their residence [redacted] Fort Worth, Tarrant County, Texas.
- That [redacted] ^{witness} was also at the residence and heard a loud banging noise coming from the bedroom where Jessica and Kimberly were located. ^{witness}
- That [redacted] went upstairs and found Jessica locked in the walk-in closet with Kimberly. Fearing that there was a problem, because of the loud banging noise, [redacted] attempted to open the door. [redacted] ^{witness} stated that the door was locked.
- That [redacted] made repeated request for Kimberly to open the door but Kimberly refused.
- That [redacted] kicked the door several times to force the door open. Once the door was opened, Jessica ran from the closet. Kimberly grabbed Jessica and held her against her will on the bed.
- Kimberly told [redacted] that she was "just loving on" Jessica and Jessica immediately replied that she (Kimberly) was trying to kill her.
- That [redacted] entered the room and observed Jessica being held against her will. [redacted] ^{witness} forced Kimberly to release Jessica. [redacted] ^{witness} had to pry Kimberly's hands and arms away so that Jessica could be released. ^{witness}
- That [redacted] spoke with Jessica and Jessica stated that Kimberly had forced her into the closet and attempted to suffocate her by placing a rag into her mouth and down her throat.

- That this case was assigned to Detective D.G. Rohloff of the Fort Worth Police Department Major Case Unit under report number 12-12752, Detective Carabajal and Detective Green interviewed [REDACTED] about the incident.
- That [REDACTED] ^{witnesses} statements were consistent when interviewed by these detectives. Further investigation shows that Kimberly could possibly have taken Jessica against her will and has currently fled the state.
- That during the course of the investigation, [REDACTED] ^{has ss} stated to Detective Green that Kimberly has shown signs of being suicidal (threats of suicide, and research on the internet on how to kill oneself).

That based on the above information and facts related to him and as a result of his investigation your affiant does believe the Kimberly Smith intentionally or knowingly placed a rag in the mouth of Jessica Smith in an attempt to smother her and then threatened to kill Jessica and herself with a knife. That Kimberly Smith is known to be suicidal and is currently holding Jessica Smith against her will and has possibly fled the state.

WHEREFORE, I request that an arrest warrant issue for the suspect hereinbefore designated according to the laws of this State.

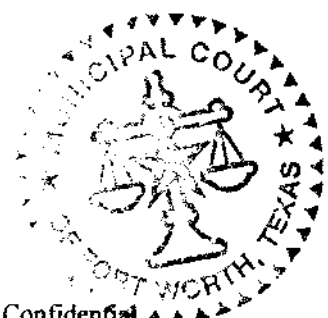
