Estuvo preso por violación por una mentira de su hija

Ella lo denunció porque él la exigía en sus estudios

Jorge, un camionero cordobés de 42 años, salió llorando de la Cámara 6^a del Crimen de Córdoba y se abrazó con Analía, su esposa, que lo esperaba también llorando. Acababan de absolverlo de una acusación aberrante, por la cual había pasado 20 meses en prisión, basado en una falsa denuncia: la violación de su propia hija, una chica que ahora tiene 19 años. Pero todo había sido una mentira, una venganza de su hija porque "el hombre era demasiado recto y quería que sus hijas fueran personas de bien, que estudiaran y que honraran a la familia", contó a Clarín Claudia Mirele, la abogada defensora de Jorge. En el pasillo frente a la sala donde se hizo el juicio, al hombre lo esperaba, además del resto de su familia, su hija mayor, quien lo había denunciado falsamente y quien durante la investigación y en el propio juicio dio marcha atrás con sus dichos. "Realmente, la instrucción a cargo de la fiscal Liliana Abad fue pésima, con vicios procesales y fallas muy gruesas", disparó la abogada Mirele. Al terminar el juicio, el fiscal de la

Cámara, Marcelo Altamirano, quien había solicitado la absolución del acusado, expresó: "Fue un hecho desgraciado. En caso de que no haya secuelas físicas en la denunciante, la Justicia debe construir desde los indicios. La menor, luego de la denuncia, explicó que su padre era inocente. Pero en su momento se temió que la joven hubiera sido amenazada para que diera otra versión de lo sucedido". El fiscal agregó que "esta persona estuvo detenida casi dos años en el penal de Bouwer. La pena probable para este tipo de delitos es de 8 a 20 años, pero por suerte los sensores de la Justicia funcionaron correctamente". Sin embargo, la presunta víctima "nunca fue sometida a un examen forense y hasta le prohibieron que visitara a su padre", aseguró la abogada defensora. En diciembre de 2007, la hija mayor, quien entonces tenía 17 años, le contó a su mamá que su papá la había estado abusando y violando desde el año 2003. Analía, la esposa del acusado, quien concurría a una iglesia evangélica, le dijo a una predicadora lo que estaba pasando. Desde el templo le sugirieron hacer la denuncia. El 7 de febrero de 2008, la Policía detuvo al camionero. "La principal bronca de la chica hacia su papá era el control estricto del hombre hacia sus cinco hijos. Mi cliente es camionero, pero había llegado a la universidad y para alimentar a su familia dejó de estudiar. Entonces, quería que sus hijos estudiaran y que no fueran vagos. Era un padre rígido que ponía controles", detalló la abogada. El detonante para que la hija denunciara a su papá fue una mezcla de venganza y celos: el le exigía que estudiara, le cuestionaba sus amigos porque a ellos no les iba bien en la escuela y encima ella le encontró en el celular un mensaje de texto de una mujer que no era su madre. Cuando Jorge cayó preso, "sus familiares fueron visitados por miembros de la iglesia evangélica, quienes les dijeron que debían vender su casa y darles dinero porque ellos los habían ayudado a liberarse del peligro y estaban en deuda". Incluso, durante la investigación, la suegra del padre sospechado declaró ante la fiscal Abad: "Yo tengo una corazonada, recibí un mensaje de Dios que me decía que algo pasaba en esa casa". Pero en el juicio negó haber visto alguna conducta sospechosa. En medio del juicio y sin pruebas del abuso, el fiscal Altamirano le propuso a la defensora Mirele

un acuerdo: "No quise, porque yo quería que también se cayera la acusación de la violación y Jorge se fuera con una absolución que limpiara su integridad moral. Y lo logramos". Ayer, al salir de la sala de audiencias, Jorge se abrazó a su familia. Su hija mayor, la falsa acusadora, lo miraba llorando desde un banco. Al verla, el hombre se acercó, le tendió la mano y le dijo: "Vení hija, te perdono".

He was jailed for rape for a lie by his daughter

She denounced him because he demanded it in his studies

Jorge, a 42-year-old Cordovan truck driver, came out crying from the 6th Chamber of Crime in Córdoba and embraced with Analía, his wife, who was waiting for him, also crying. They had just absolved him of an aberrant accusation, for which he had spent 20 months in prison, based on a false accusation: the rape of his own daughter, a girl who is now 19 years old. But it had all been a lie, a revenge of his daughter because "the man was too straight and he wanted his daughters to be good people, to study and honor the family," Claudia Mirele, defense attorney for Jorge, told Clarín. In the hallway opposite the room where she was the trial, the man expected, in addition to the rest of his family, his eldest daughter, who had falsely reported it and who during the investigation and at the trial itself reversed their statements. "Actually, the investigation in charge of the prosecutor Liliana Abad was terrible, with procedural defects and very thick faults," shot the lawyer Mirele. At the end of the trial, the prosecutor of the Chamber, Marcelo Altamirano, who had requested the acquittal of the accused, said: "It was an unfortunate event, in case there are no physical sequels in the whistleblower, the Justice must build from the signs." The minor, after the complaint, explained that her father was innocent. that the girl had been threatened to give another version of what happened. "The prosecutor added that" this person was detained almost two years in the prison of Bouwer. The probable penalty for this type of crime is from 8 to 20 years, but fortunately the sensors of Justice worked correctly. "However, the alleged victim" was never subjected to a forensic examination and was

even prohibited from visiting her father "In December 2007, the oldest daughter, who was then 17 years old, told her mother that her father had been abusing and raping her since 2003. Analía, the wife of the accused, who was attending to an evangelical church, he told a preacher what was going on, and from the temple they suggested that he make the accusation, and on February 7, 2008, the police stopped the trucker. "The girl's main anger towards her father was control strict man towards his five children. My client is a truck driver, but he had come to the university and to stop feeding his family he stopped studying. So, he wanted his children to study and not be lazy. He was a rigid father who put controls," explained the lawyer.
