AFFIDAVIT FOR PROBABLE CAUSE

Comes now Anthony Howard, who hereby swears upon HIS oath, deposes and says:

1. I am a Law Enforcement Officer with the Westfield Police Department.
2. I am filing this affidavit for probable cause in support of the charges of Obstruction of Justice, False Informing, against Shelly M Korous, a White, Female, DOB: June 14, 1978, height: 5'06", weight 125 lbs., with Blonde hair and Blue eyes.
3. On June 18, 2018 at approximately 10:20 pm, Officer Anuar Velazquez responded to 316 Abbedale Ct., Carmel, Hamilton County, Indiana, in regard to a battery. Upon Officer Velazquez's arrival, he observed the garage door open and then observed a male later identified as Greg Thiel, Shelly Korous's (victim's boyfriend), walking out from inside of the house. Officer Velazquez's advised that he then walked into the house from the garage and saw Shelly Korous laying on the floor covered with a brown blanket and her jeans to her ankles. Shelly Korous was crying and yelling for help. Shelly Korous stated that Jack Rebolledo was still in the house in the bedroom near the hallway where she was found. Officer Velazquez checked the bedroom and no one was found. Officer Velazquez then returned to where Shelly Korous was laying on the floor. Officer Velazquez reported that Shelly Korous had red marks on her arms and abrasions on her upper chest area. Shelly Korous also had black marks, from some type of markers on her face and shirt. Shelly Korous' shirt was ripped on the right shoulder strap. Shelly Korous advised Officer Velazquez that her ex-husband Jack Rebolledo had assaulted her. Shelly Korous reported that she did not see Jack Rebolledo, but heard and recognized his voice.
4. Shelly Korous stated to Officer Velazquez that shortly after her boyfriend, Greg Thiel, dropped her off at her house, she opened her overhead garage door, and proceeded in. Once inside the garage she closed the door and started to go inside her home. Shelly Korous advised that as was about to enter her home, she heard the garage door go back up. Shelly Korous stated that before she could turn to see what was happening, she was grabbed on the back of the head by her hair, she then heard the voice of her ex-husband, Jack S. Rebolledo, say, "you will always be my whore" and then he said, "I am going to kill you". Shelly Korous reported that her head hit something and she fell unconscious. Shelly Korous remembers waking up to her son and Officer Velazquez standing over her.
5. Shelly Korous was then transported to the hospital by ambulance and she requested that Officer Velazquez ride in the ambulance with her. Officer Velazquez reported that on the way to the hospital Shelly Korous' injuries became more apparent. Shelly Korous began to complain about

severe pain to vaginal and abdominal areas. Officer Velazquez stated that the other injuries to Shelly Korous body were very evident. Officer Velazquez advised that Shelly Korous had a large knot on the back of her head, along with red marks around her neck consistent with someone that has been strangled. Shelly Korous also had large abrasions on the sides of her neck and bruising on her inner thighs. Officer Velazquez also advised that Shelly Korous had multiple scratches and scrapes on her arms and abdominal area.

6. On June 18, 2018, I Detective A. Howard spoke with Shelly Korous' 12-year-old son, LK. LK advised that he was upstairs taking a shower when he heard his mother screaming, help me help me. LK stated that once he located his mother he saw that she was in and out of consciousness so he called 911. LK reported that while he sat with his mother, (Shelly Korous) she stated to him "he did this to me". LK advised that he knew that his mother was talking about Jack S. Rebolledo.
7. On June 19, 2018, I spoke with Shelly Korous while she was at Methodist Hospital. Shelly Korous stated she and her boyfriend, Greg Thiel were at the home that they had just acquired together, cleaning it. Shelly Korous advised that at approximately 10 pm, she was dropped off by Greg Thiel in her driveway, by her garage door. Shelly Korous reported she opened the door and went inside the garage and closed the door. Shelly Korous advised that just prior to the door closing all the way; she heard the door start back up. Shelly Korous stated that before she could turn and see what was occurring, she was grabbed by the hair on the back of her head. Shelly Korous stated that she then heard the person behind her say; "you will always be my whore", and then possibly something about killing her. Shelly Korous advised that as the person behind her spoke, she immediately recognized the voice as that of her ex-husband, Jack S Rebolledo. Shelly Korous reported that the next thing she remembered was waking up with extreme pain in her vaginal area, and her son and Officer Velazquez standing over her. Shelly Korous advised that she assumed she was raped due to the extreme pain in her vaginal area and her state of undress.
8. Shelly Korous then submitted to a forensic sexual assault exam, at which point she was taken to a different room in the hospital. On June 19, 2018, I, Det. Howard contacted Methodist Hospital and spoke with a representative from the Center of Hope, (the division that takes care of forensic examining). The nurse advised that there was severe trauma to the vaginal area of Shelly Korous, which normally comes from forced sexual intercourse.
9. On June 19, 2018, I received an arrest warrant for Jack s Rebolledo for the following charges, 2 counts Rape, 1 count Burglary, 2 counts domestic Battery, 1 count Strangulation, 2 counts Invasion of Privacy.
10. On June 20, 2018, I was contacted by the Hamilton County Prosecutors Office and advised that Jack S Rebolledo was on an flight from Baltimore, Maryland to Indianapolis, Indiana, at the time Shelly Korous reported that Jack S Rebolledo Rape and Assaulted her. Jack S Rebolledo' s attorney provided documentation that Jack S Rebolledo boarded Southwest flight 1990 out of Baltimore at 8:19 pm, on June 18, 2018, and arrived in Indianapolis, Indiana, at 9:46 pm, on June 18, 2018. Jack S Rebolledo then provided a parking receipt from Indianapolis Airport economy lot that show Jack S Rebolledo paid and left the lot at 10:14 pm, on June 18, 2018. The first call

to Hamilton County dispatch from 316 Abbedale Ct, Carmel, IN, reference the Rape and Assault was received at 10:20 pm, on June 18, 2018. Google maps show that the shortest distance from 316 Abbedale Ct, Carmel, IN, to Indianapolis International Airport is 34.3 miles with a drive time of 41minutes. (10:14 pm, + 41 minutes= 10:55 pm.)

11. On June 22, 2018, an Order on State's Motion to Dismiss was granted and all charges related to this case were dismissed without prejudice. (Cause No 29D03-1806-F1-004304).
12. On June 22, 2018, a follow-up interview was conducted with Shelly Korous. Shelly Korous advised that she and her boyfriend, Grey Thiel had just purchased a house together and the closing was that very day. Shelly Korous advised that after closing, her son, LK, Greg Thiel, and herself, grabbed a bite to eat, and then returned to the new home to start cleaning it. Shelly Korous reported that once back at the new home, Lk was upstairs cleaning his bedroom, and she and Greg Thiel decided to have sex in the basement. Shelly Korous stated that after she and Greg Thiel were finished having sex they both went upstairs and began cleaning the kitchen. Shelly Korous advised that a short time later, her daughter KK, was dropped off at the new home. Shelly Korous stated that they all cleaned for a little while longer and the children started to get tired so Greg Thiel took them both back to the 316 Abbedale Ct, home. Shelly Korous reported that Greg Thiel returned a short period later and they both continued to clean the new house until around 9 pm. Shelly Korous stated that she and Greg Thiel left the new home and shortly arrived back at the 316 Abbedale Ct address. Shelly Korous advised once back at the 316 Abbedale Ct. address, she asked Greg Thiel to spend the night. Shelly Korous said that Greg Thiel declined, stating that he had to get up early and start working on the move. Shelly Korous advised that she was upset over this.
13. Shelly Korous advised that once she was dropped off, she went into the garage and messed around for a short period before she started to go into the house. Shelly Korous stated that as she started into the house, she pushed the garage door button and the door started to close. Shelly Korous reported that as she started to step into the house, she heard the garage door start back up. Shelly Korous said that as she turned to see why the door was going back up, she was grabbed by the hair on the back of her head. Shelly Korous stated that she then heard a voice say "you will always be my whore".
14. Shelly Korous now stated that she could not be 100% sure the voice was that of her ex-husband, Jack Rebolledo. Shelly Korous was asked what had changed her mind, about the voice she heard, not being, Jack S Rebolledo, when at the initial interview she was 100% sure it was Jack S Rebolledo's voice. Shelly Korous could not give an answer, she stated that she was just not sure now.
15. Shelly Korous said that the next thing she remembers is waking up briefly with her son, LK, and Officer Velazquez standing over her.

16. Shelly Korous was then showed the pictures of her injuries that were taken on June 18th and 19th 2018. Shelly Korous looked at the photos and agreed that they looked self- inflicted. Shelly Korous advised that while in nursing school she had worked for a forensic doctor and one of her jobs was setting up injuries on cadavers. Shelly Korous again looked at the photos, and again stated that the injuries do appear to be self-inflicted, but she does not remember doing that to herself.
17. Shelly Korous stated that she has been under a lot of stress lately, which may have triggered her memory loss. Shelly Korous commented that shortly after the incident, she was speaking with her mother, and she told her that something in her mind, does not seem right with what had occurred on June 18, 2018.
18. As Shelly Korous spoke, the more distraught she became, advising that with everything that she has been going on in her life lately, the stress has been weighing very heavy on her. Shelly Korous advised then that when she was around 18 years old, she was placed in a mental health facility. Shelly Korous stated that she was placed in the facility for attempting to commit suicide.
19. Shelly Korous continued to look at the photos of her injuries and continued to state that the injuries are self-inflicted but she just does not remember doing this to herself. Shelly Korous advised that she does need professional help.
20. On July 12, 2018, I contacted Leslie Cook, from Fort Wayne, Indiana, Sexual Assault Treatment Center. Leslie Cook has been a registered nurse for 25 years and practicing as a sexual assault nurse examiner (SANE) for 23 of those years. Leslie Cook is board certified to provide care to adults, adolescents and children. Additionally, Leslie Cook is an elected Coroner, board certified in death investigation and has 20 years of experience in conducting external examinations of the deceased as well as the living.
21. I requested that Leslie Cook take a look at the photos of Shelly Korous injuries that were taken the night of the reported incident, at Methodist Hospital. The photos were taken by the on duty SANE nurse at the time of the examination. Leslie Cook was also provided follow up photos that were taken 4 days later, at the Westfield Police Department. The packet given to Leslie Cook also included the full report from the Methodist SANE Nurse and a brief overview of what was reported by Shelly Korous.
22. On July 24, 2018, Leslie Cook asked what my concerns with Shelly Korous injuries were. I informed Leslie that we were concerned that Shelly injuries were self-inflicted, and she possibly fabricated the report on June 18, 2018. I informed Leslie Cook that due to injuries occurring predominantly on Shelly Korous left side, (Shelly is right handed), and the precision, (straight lines), and the lack of injuries in some areas, (breast augmentation area and tattooed area), I believed evidence points towards self-inflicted injuries. Leslie Cook advised, there is no way to


tell 100% if injuries like these are self-inflicted, but she believed that I was on the right track. I requested that Leslie provide some type of documentation on her educated opinion on the photos.

23. On August 1, 2018, I received a letter, by email, from Leslie Cook containing her educated opinion on Shelly Korous injuries. Leslie Cook stated the injuries reviewed in the photos appear to be from blunt force and /or sharp force trauma. The bruises appear to have a variety of colors, many with yellow edges. Leslie Cook advised that generally speaking, one cannot date a bruise with specificity, however they will show multiple colors as they age, beginning with red/purple progressing down to brown/yellow. Leslie Cook states there are multiple superficial red linear abrasions with some that appear to be intermittently scabbed. Leslie Cook reported that sharp force injury cannot be ruled out on at least one of the 2 linear injuries to the chest/upper left breast area where those injuries appear to have more depth and have what appears to be dried blood.
24. Leslie Cook stated the injuries to the genital area include a red abrasion to the right side of the clitoral hood. Leslie Cook advised that she cannot determine if there is a red abrasion or laceration to the inner vestibule of the female sex organ but it does appear to be bleeding and either injury would be from blunt force trauma.
25. Leslie Cook reported that some of these injuries could be consistent with the timeframe established, however, the bruises with the yellow edges would be concerning if the patient is reporting these to be within the 3 hour timeline. The superficial linear abrasions seen to the arms, neck, chest and abdomen could be consistent with a report of infliction by an offender but they could also be consistent with injuries she has seen where patients have reported self-harm.

Except as specifically noted, all the above events occurred in Hamilton County, Indiana.

I swear under the penalties of perjury as specified by IC 35-44-2-1, that the foregoing representations are true.
