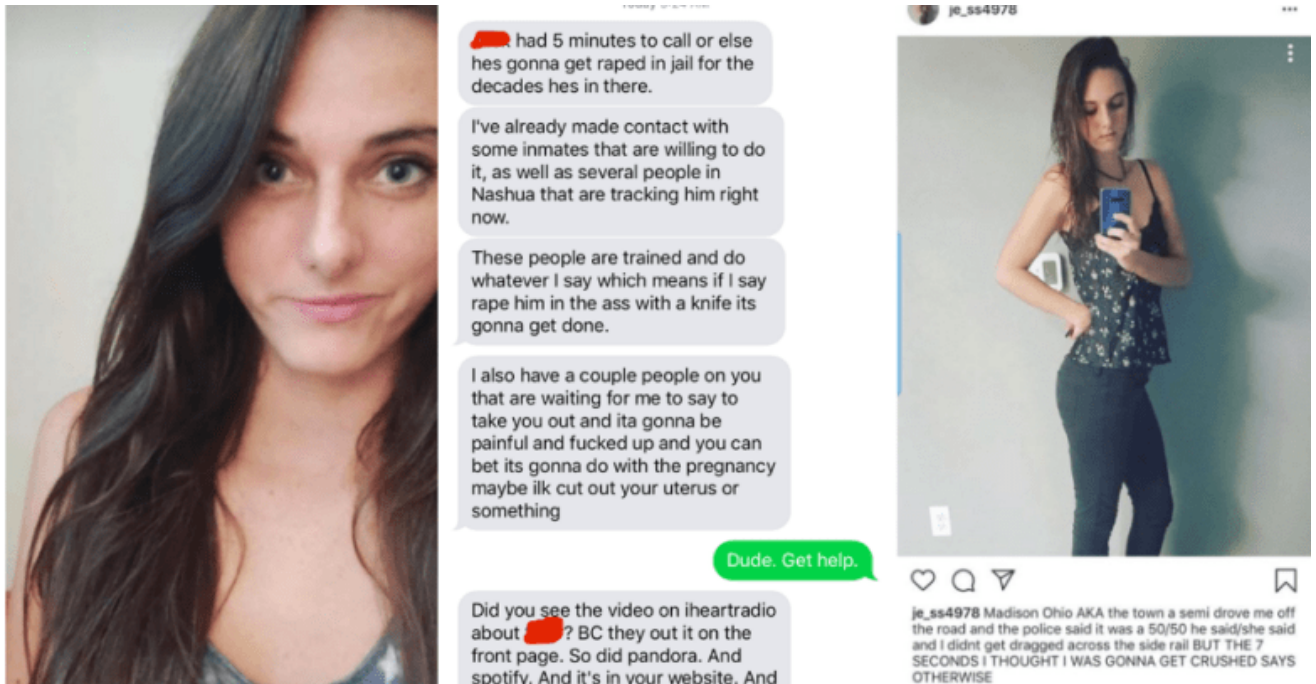

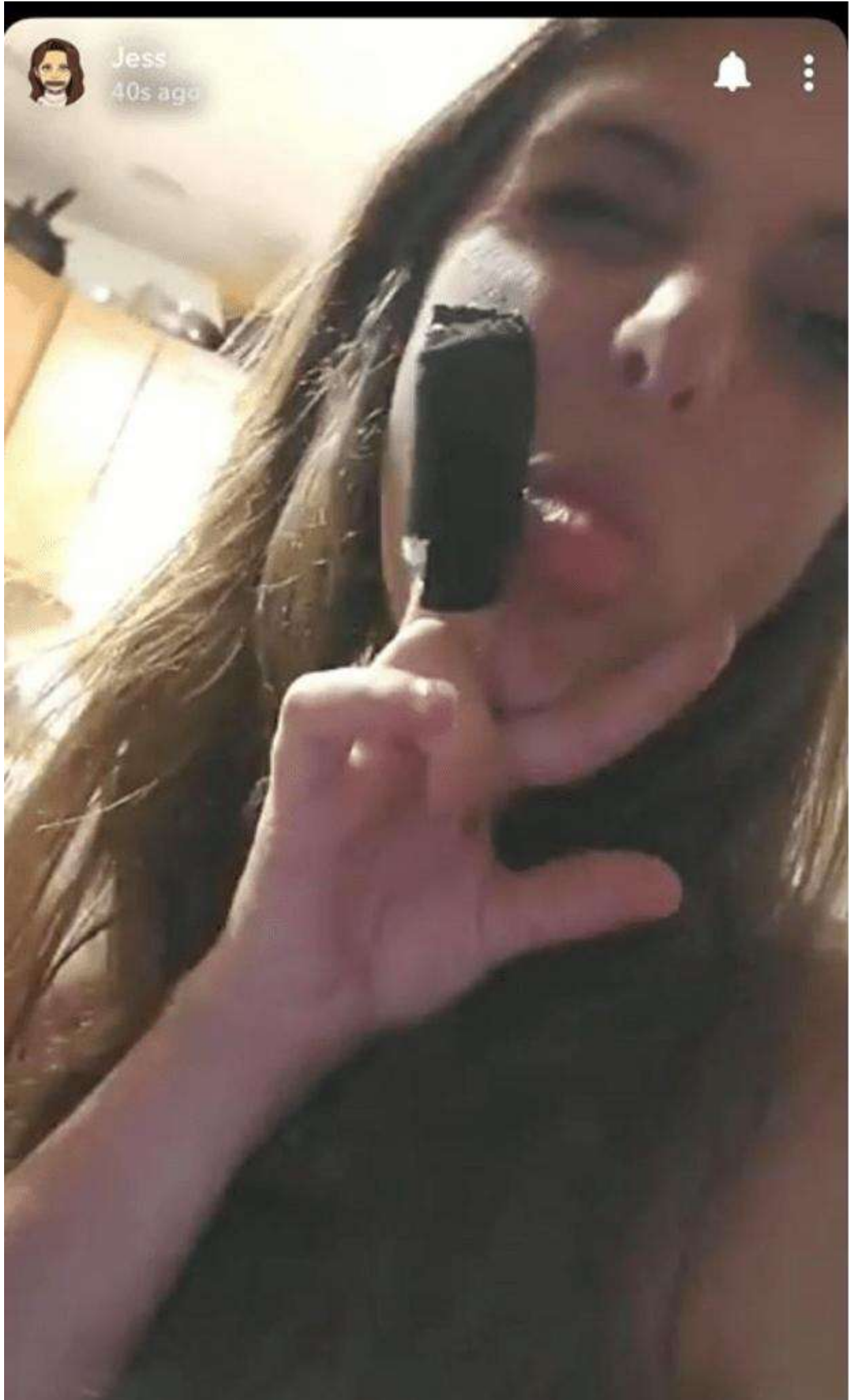


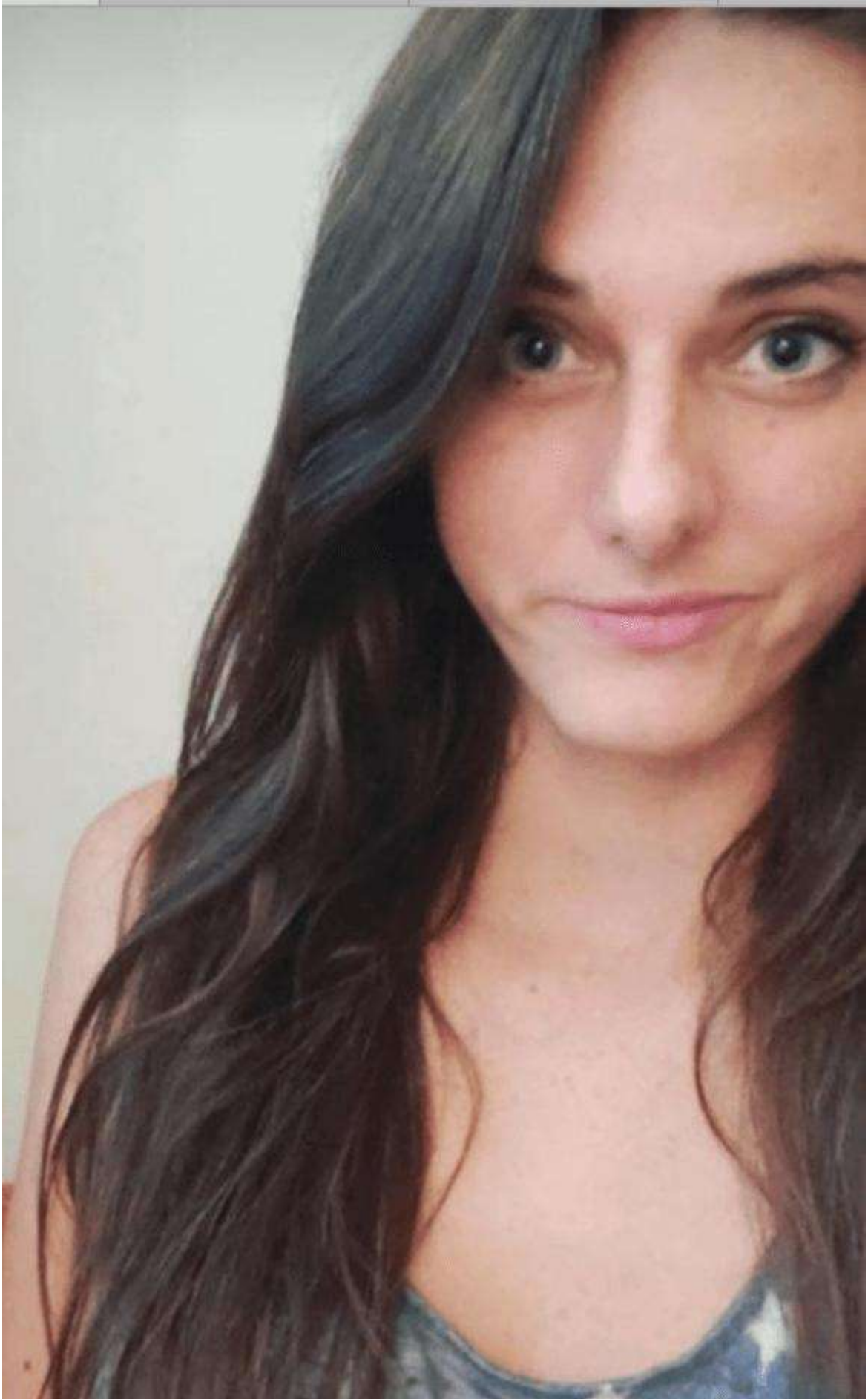

For my cooperative education at Northeastern, I worked as a residential counselor in psychiatric rehabilitation for Vinfen. For my training, I was certified in MAP, CPR, Warfarin and Clozaril administration, and person-centered interventions. In particular, I was taught about the stages of change, and how to meet the client where they were at, as well as how the client should be seen holistically in the context of their environment.

My duties as a residential counselor included performing interventions that would assist the clients in performing their activities of daily living. These included skills training, motivational enhancement, crisis intervention, and psychoeducation. I would often schedule appointments for clients, coordinate with the other professionals that worked in the house such as the nurses, administer medication, and connect the clients with community resources that would increase their integration into the community. In addition, I had to help manage the responsibilities of the house, such as cleaning, cooking, and ordering supplies.

I worked at Vinfen full time from March 2017 to August 2017 and then worked as a relief residential counselor from September 2017 to September 2018.

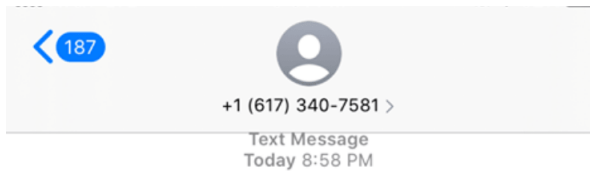

She also made it clear to the man who ended things with her that she was going to go to the Cambridge Police to make up a story about being raped if he didn't pay her off, and threatened to stalk him at work.

It's why I'm skinny and vomit a lot and I'll be dead by 30 and so will you. Also you're the only guy I fucked without a condom and you know this to be true so fight me in court I'll get a paternity test. Also an officer will be calling you about the pregnancy. She left a voicemail vowing to show up at his house, contact all of this future employers, and file a false police report that he raped her.

When that didn't work she threatened his boss some more, vowing to take all his money unless the employee who dumped her called her back.

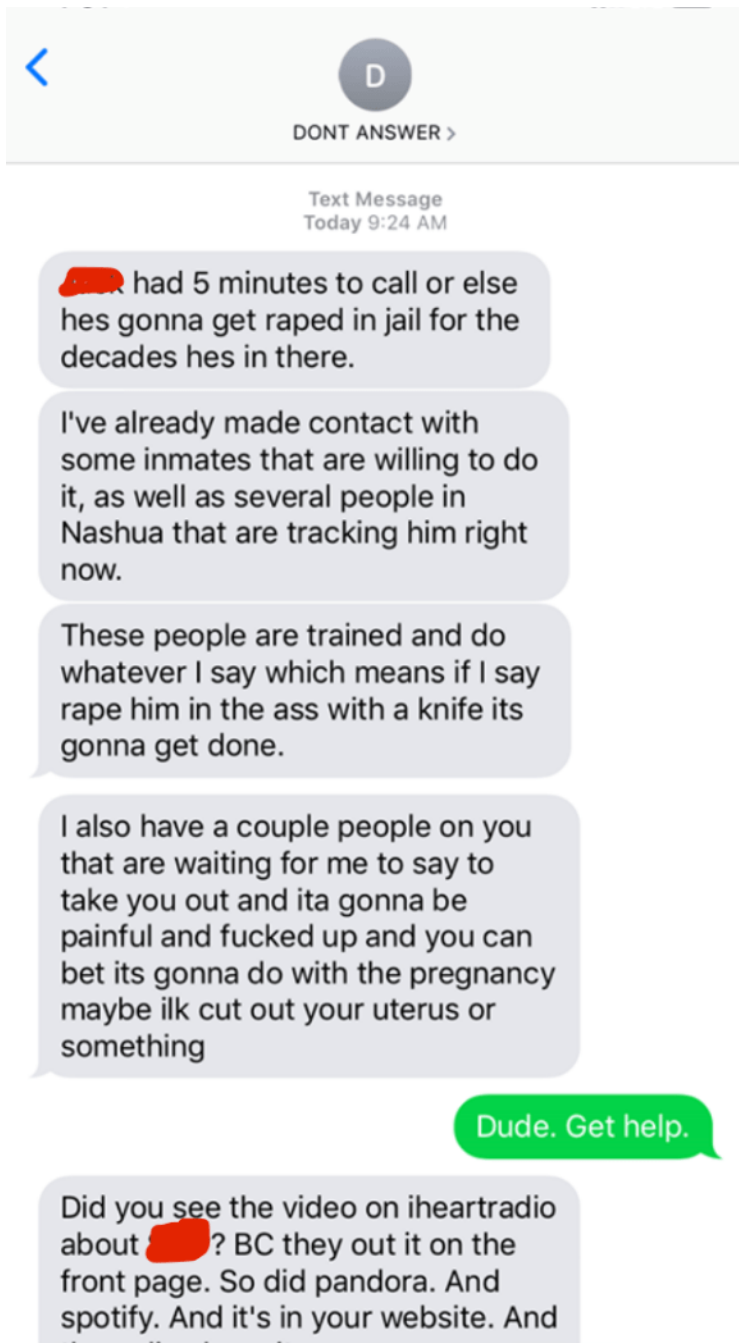


I was just played your recorded phone call when jess told you she was pregnant and you said "wow you really are fucking tapped". That will be going on our website and we will be making sure that you never are able to run a company again because of your abusive behavior. We will see to it that you are placed promptly in jail and jess is financially compensated for the abuse that she suffered by [REDACTED] and [REDACTED]

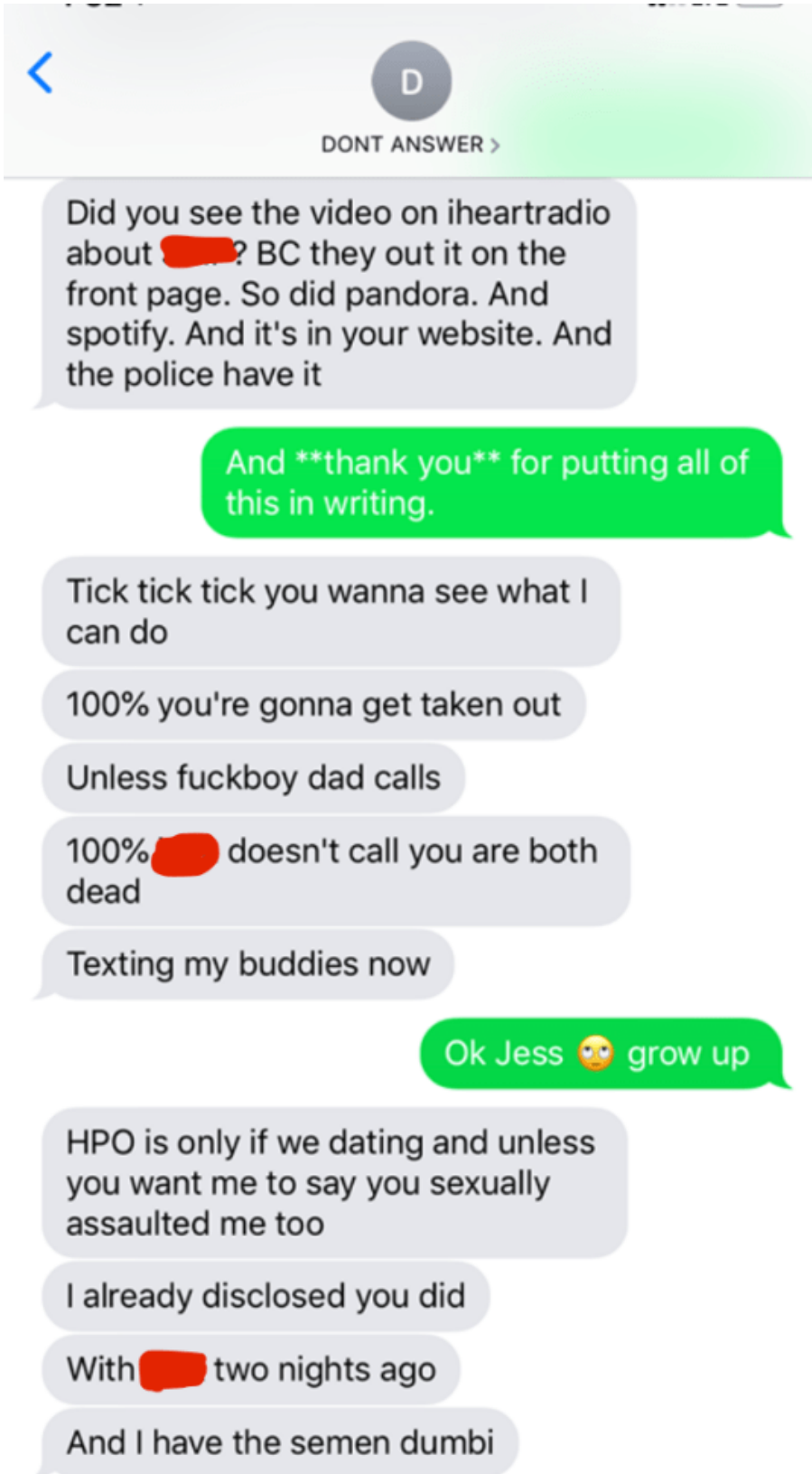
Sir, [REDACTED] got this poor girl pregnant. The fact that you are not taking this seriously is disgusting. We will be making sure [REDACTED] is taken down and [REDACTED] gets what he deserves in jail.

Please contact our attorneys if you have any further comments on the matter. We will be seeking justice for Jess.

The Thanksgiving threats continued, as she vowed that both the employee and employer would be raped by her gang raping connections in jail, who she keeps on speed dial whenever an incoming prison needs a good raping.










She continued to pretend that iHeart Radio and Pandora were involved, vowed that they would be "taken out" 100% dead, claimed that she had semen proof (even though she was impregnated), and even vowed to make up a lie that the boss sexually assaulted her too.



She spent all day on Thanksgiving harassing these people.

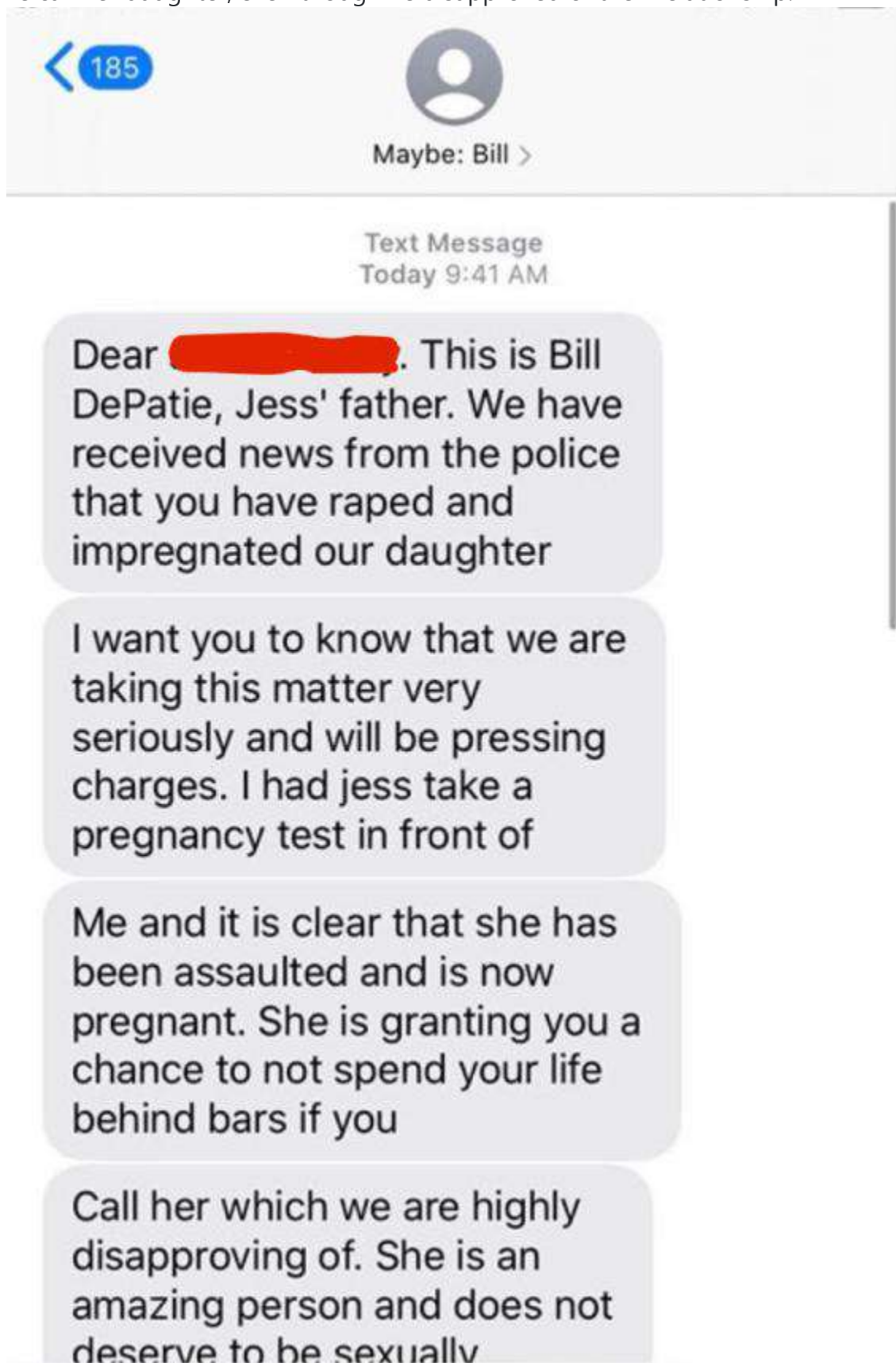

She left another voicemail claiming to have filed a police report with the Cambridge Police and said that she would take all of his money, said she didn't believe in abortion, and vowed to go to his work events and tell patrons that he raped her if he didn't call her back, in which case she would stop threatening him.

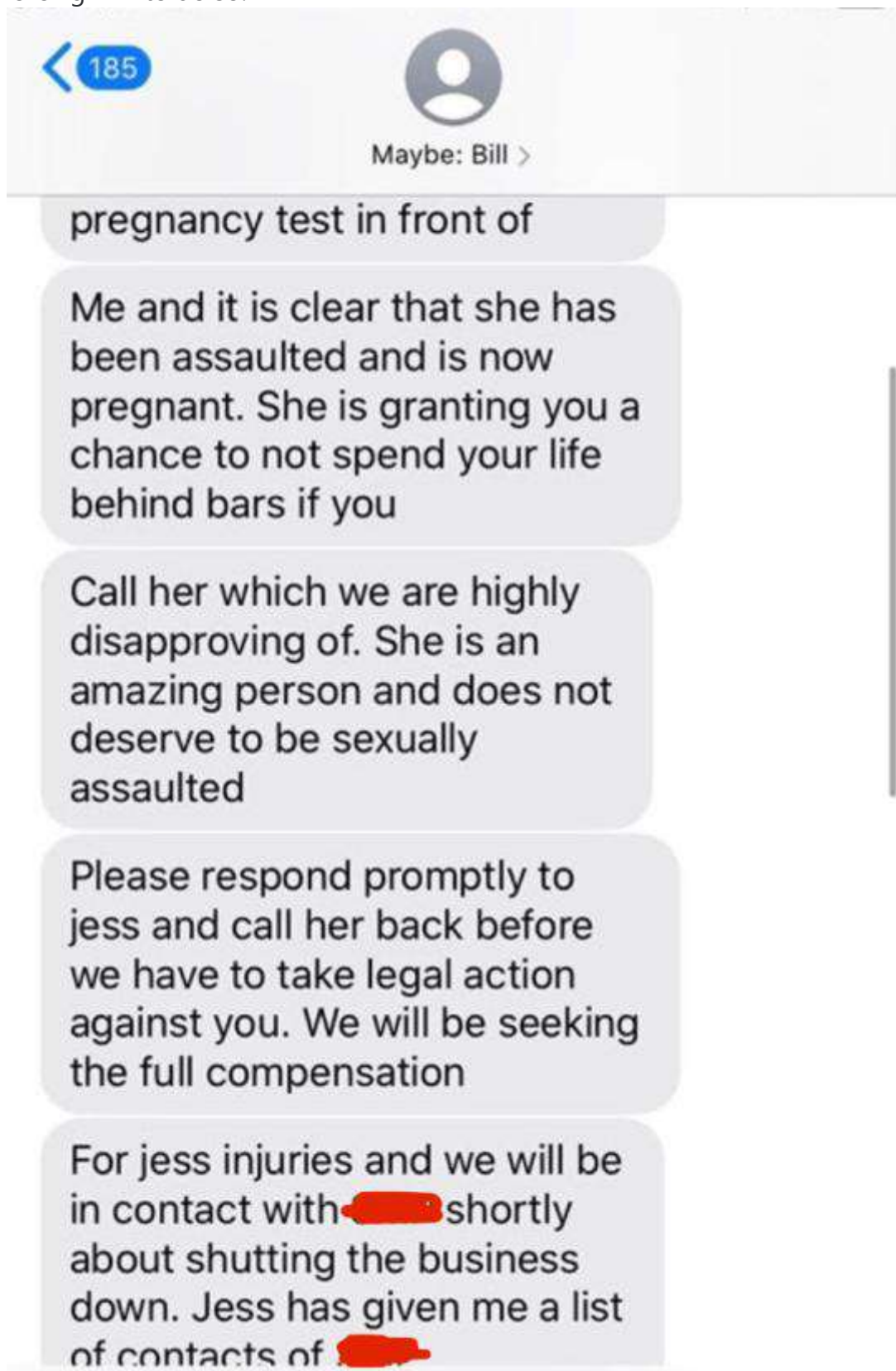
*"Get ready for a fun couple of weeks, because I'm really, really good at this s\*\*\*."  
"I've waited so long for someone to piss me off so I can go after them."*

As entertaining as this is as an outsider, it's actually very sick and dangerous, and she should be in jail. No one should have to live like this because they swiped left on the wrong woman.

Meanwhile, the employee was getting messages from her "Dad" Bill DePatie (which was obviously her), claiming that he performed a rape kit on her and demanded that he call her daughter, even though he disapproved of their relationship.



“Bill” said that he was kicking his daughter out for be a pregnant harlot, even though she lives on her own in Cambridge, and blamed the imaginary baby daddy for forcing him to do so.

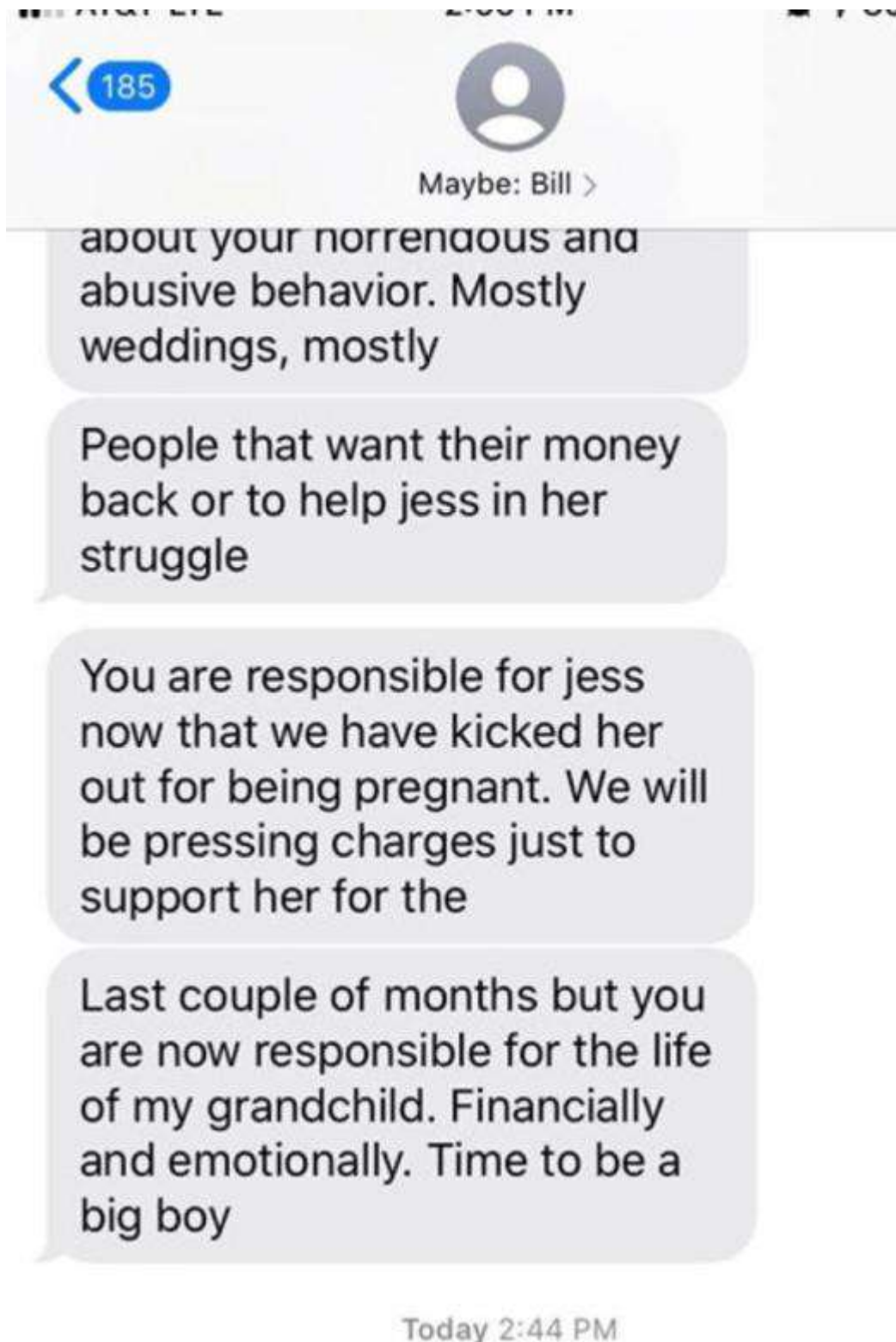

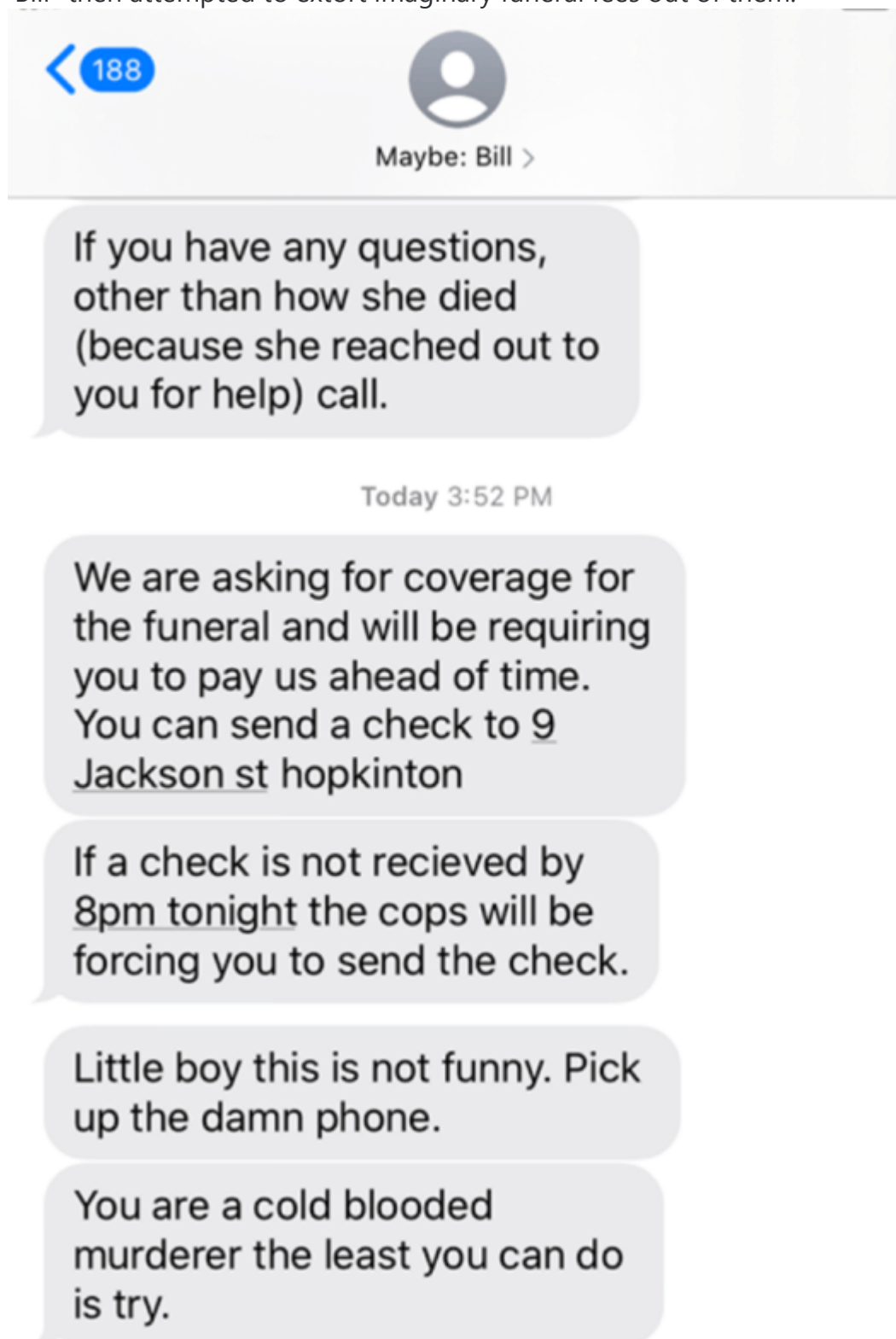
Will be charged with double homicide domestic abuse and rape

This is Jessica's father bill DePatie. I am writing to you because you have killed my daughter and my granddaughter.

Jess left jack a voicemail in her last minutes. I am asking from you and [REDACTED] to tell me why she did what she did.

If you do so, I will leave the two of you alone even though you murdered my daughter.

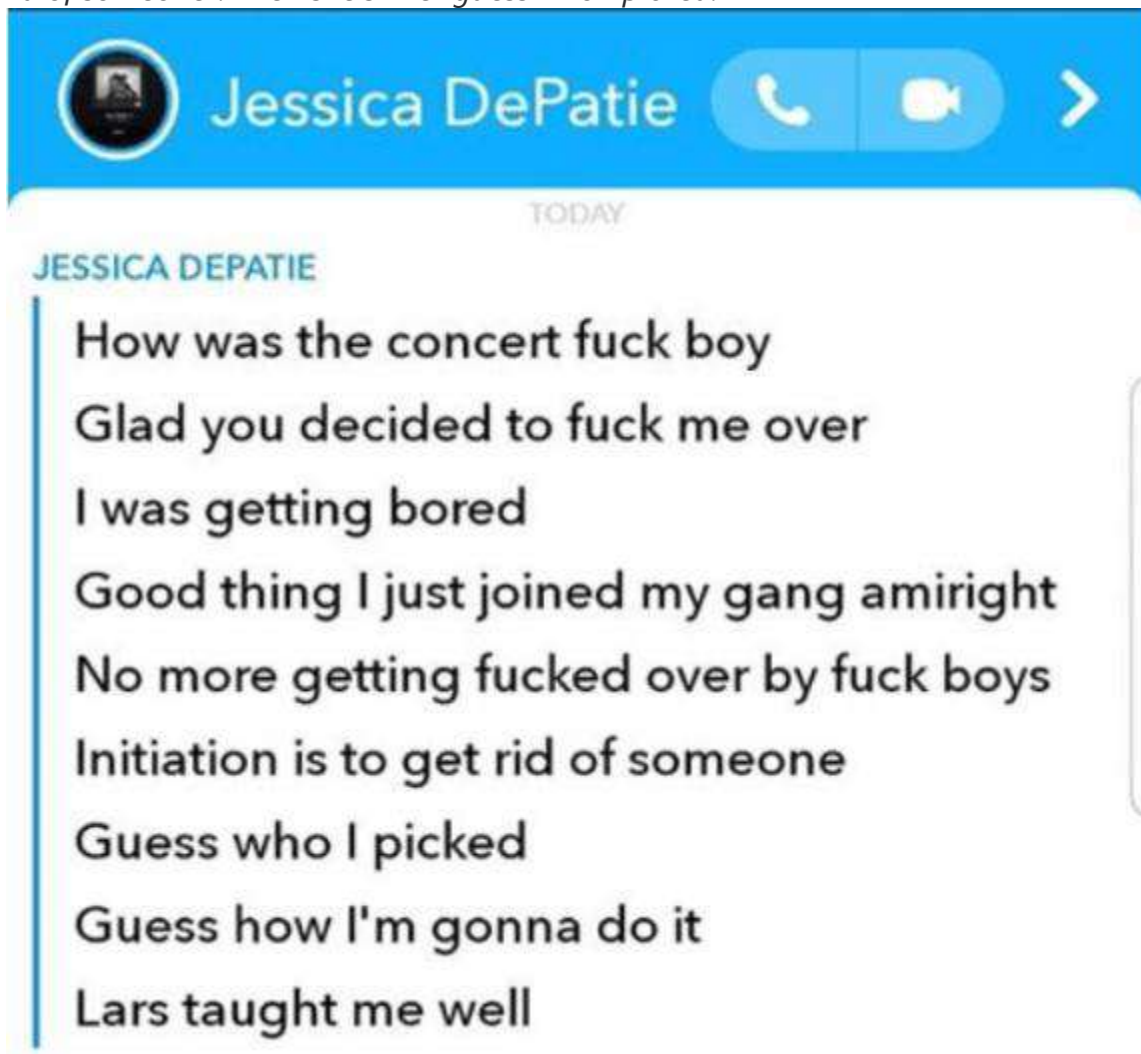
This isnt funny. Do you want the police report?

Yes, I do.

And before she “died” she also left a voicemail pretending to be a Hopkinton cop, a town she doesn’t live in.

But these aren’t the only people she’s done this to. Another victim we found by searching her name on Facebook told us this story:

*I’ve been friends with her since 2015. We were planning on going to the Logic concert last month, and I wanted to bring another friend. When she found out she lost her fucking mind and started calling my friend a whore, so I cancelled my plans with her. The next day she told me she had joined a gang and that the initiation was to “get rid of someone”. Then she’s like “guess who I picked.”*



Totally normal.

A woman who dates and has a child with Jessica’s ex-boyfriend (over 3 years ago), tells us that Jessica has been threatening her annually, and even showed up drunk at her house in Milford after filing a false report with DCF in a vain attempt to have her crotch fruits confiscated.

*"So I technically don't even know Jess. Jess just so happens to be my boyfriend's psychotic ex girlfriend. When I say psychotic I mean this girl has no limits or boundaries when it comes to harassing people. A little background history I can give you about her is that 3 years ago her and my boyfriend which unfortunately I'm not allowed to give his name because he doesn't want involvement with this, they were in a very serious car accident and he saved her life and ever since then she's had some pretty serious mental health issues. This time every year Jess goes off the deep end and self destructs because of her PTSD.*

*I know that personally because every year my boyfriend receives phone calls from her saying ridiculous things such as if you don't break up with your girlfriend I will call dcf on your girlfriend and make sure the kids get taken which this time she did call dcf and luckily they didn't take my children because I had the messages to prove it was a phone call out of spite.*

*After Jess showed up to my house on November 6th and 9:30 pm piss ass drunk Milford Police department sent her on her way with mommy and daddy because she couldn't pass her sobriety tests, she called DCF on me just like she said she would in those messages and they called me November 8th around 5 pm as I was heading out the door for my daughters 11th birthday party and they came out November 13th at 5 and the accusations Jess claimed me of were ridiculous."*

She was once again wise enough to put it all in writing.





She clearly has lost her marbles as can be seen by these bizarre messages she sent the same woman.

Yikes I vent to the bathroom and screamed his name for a couple minutes and came back and did orientation, fuck me right

I literally learned that "no was an option" last week

Power and privilege is not a defining aspect of my life

Waiting for the day I get the balsl to be like "this is hard for me bc I have to come up with a fucking cultural identity for all my identities"

and lol one of them is a lesbian and I have a society in my head, they interact and tell jokes and that's why I'm funny" and just see what they do

Lemme ask my abandoned borderline identity that's trying to kill itself if it should consider checking its privilege before it tries to kill itself because it might be offending minorities that dont have the privilege to kill themselves. My pain is racist, my tears are racist, the fact that I got into the situation with lars is racist, I can never understand diversity or trauma bc I am a middle class able bodied white woman

Identify yourself: well this could be for 20 minutes or for a couple hours, or the dom one for a couple days, but I'm a junkie with track marks and black eyes that's walking around, looking for a spot I can lay down and die. and everyone is judging me bc they can see the bruises. But I'm an able bodied white woman with power and privilege and I oppress people by existing. And triggered



myself and now I'm my parent identity that's entire purpose is to be the mom that I needed but never got and I'll sacrifice everything to put something in a better place. Up, shit, now the adolescent is coming out and I'm gonna rage and say immature stuff. My sexuality? One of my identities is a lesbian, but one is conservative and so that part is not allowed to be a lesbian. Yikes I'm so privileged I oppress myself

I'm so privileged trauma made my mind spilt into these discrete behavioral states, ways of being, facets. Blessed I gotta change my life to compensate so everything can coexist. Taking long drives so they can talk and interact and build a coherent narrative to hang out with someone and try to be a "whole, stable person". Not wearing headphones when you run so the identities can all take part in the activity. Learning to politely ask identities to quiet down a little or go twiddle their thumbs because they are

for an actual other real person

Mah white middle class able bodied heterosexual household that repressed emotions and affections to a fault taught me to have DID.

I'm so done

I have to turn in an essay and I eloquently told them to eat shit

Considering writing "eat shit" and putting it at the end of my essay

"Eat shit from all of my oppressed and discriminated against identities you entitled bigots"

How would you describe yourself to other people: "I feel like a mix of colors and energies that bring different emotions, memories and different ways of being. Everything is relative, everything is dynamic, the only thing that is real is the interaction

because you are projecting your energies and colors and I am and together we are watching them mix and interact into something genuine and beautiful"

What is therapy: there's two people that sit in chairs facing each other and they vomit up a bunch of charged intellectual philosophical garbage and together you work through and make sense of it in a way where the client can go about their life in a more productive manner and be happier and have a greater understanding of their sense of being

"People are gonna look at you and interact with you in a certain way because you're white"

Then I'll challenge them to think of me as something else and show them that I am more than that

Bish a client nervously told me he had a habit of getting mad and breaking his cell phone and my response was, "lmao one time I did that and shouted, 'fuck the

for a bit and we got into the gross weird uncomfortable parts of it. What did it feel like, can you make metaphors or jokes, how would you describe it and moved towards, what were some of the consequences, what are some thought patterns I should go through first etc

African American client 30 yrs ptsd from getting stabbed vs me, white (you know me). I bet after I said that he wasnt think "white counselor, white counselor, white counselor" he was like, i can actually be real around this person

Never broke his cell phone or electronics in anger again, 8 months #therapied

Also side note, your classmates in grad school are scarier to talk to than a raging client with PTSD.

I learned that inpatient. When I got beat up by all the ER docs and was drugged up, I lost my memory and actually didnt remember the first day inpatient. I was apparently screaming and threatening people with no memory. Woke up the next day, didnt realize the previous day happened, and was interacting with people. One of the people said, "you're so cool and you were so scary yesterday". I told them it was the drugs and that I was sorry and they laughed and told me it was cool and were friends with me after that. Normal people arent so open or forgiving, even if it isn't your fault

Can we genocide neurotypicals

Start with the neurotypicals that identify as having a mental illness (I'm depressed bc I only get 85s on my test) and write the books on how to deal with major psychological issues (self-identified depressed person writing a book about how to overcome sudden, traumatic loss of a parent during early formative years)

If you want to see my essay that says "eat shit and let me learn" while hiding behind existentialism, philosophy, professionalism, a touch of (ew) multiculturalism, lemme know. Also writing a paper about how with dissociation, suicide isn't suicide its homicide because it's always one identity

OK then.

Jessica DePatie is in serious need of psychiatric help. I feel bad for her parents because they probably know it, but are powerless to do anything since Jessica is an adult. If they are aware, and are contributing to this in any way though, they're even more at fault. Jessica is trying to ruin a lot of people's lives, is extremely dangerous, and should be in jail or in a mental institution. Those text messages show that she has committed a number of crimes, including extortion, death threats, and impersonating a police officer. More than anything, Tinder has an obligation to keep people like this off of their platform, because it's dangerous for other users. Platform access is a civil right, but your civil rights can be stripped from you when you commit a crime.

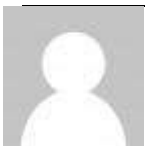
