Dømt for falsk anmeldelse af voldtægt

**19-årig pige fra Frederikshavn fik 14 dages betinget
fængsel for at lyve om påstået voldtægt**

FREDERIKSHAVN: En blot 19-årig kvinde fra Frederikshavn fik sig en plet på straffeattesten ved retten i Hjørring mandag.

Her blev hun idømt 14 dages betinget fængsel for falsk anmeldelse af en voldtægt.

18. oktober ved 01-tiden om natten havde hun anmeldt en voldtægt til Nordjyllands Politi. Den dag havde hun forklaret politiet, at hun var blevet voldtaget af to udenlandske mænd på en parkeringsplads ved et diskotek i Frederikshavn.

I retten forklarede pigen, at hun havde haft en episode med en mand, der ville med hende hjem. Det havde hun afvist. Herefter var hun gået til en ekskæreste, der havde forstået hende sådan, at hun var blevet voldtaget, og han havde derfor anmeldt sagen til politiet.

Da politiet kom til stede, havde hun - ifølge sin forklaring i retten - ikke fået sagt ordentligt fra overfor voldtægtsanklagen, men i stedet fastholdt forklaringen om voldtægten.

- Men da politiet gennemgik beviserne - blandt andet en videoovervågning - kunne de konstatere, at hendes forklaring om voldtægten ikke stemte, og hun tilstod da også den falske anmeldelse, forklarer anklager Lotte Nielsen, Nordjyllands Politi.

Kvindens alder og en i øvrigt indtil denne sag pletfri straffeattest var medvirkende til, at dommen blev på de 14 dages betinget fængsel. Den 19-årige kvinde modtog dommen.

Convicted of false report of rape

19-year-old girl from Frederikshavn was given a 14-day suspended sentence for lying about alleged rape

FREDERIKSHAVN: A 19-year-old woman from Frederikshavn got a spot on her criminal record at the court in Hjørring on Monday.

Here she was sentenced to 14 days' probation for falsely reporting a rape.

On October 18 at 01:00 at night, she had reported a rape to the North Jutland Police. That day she had explained to the police that she had been raped by two foreign men in a parking lot at a disco in Frederikshavn.

In court, the girl explained that she had had an episode with a man who wanted to take her home. She had rejected that. After that, she had gone to an ex-boyfriend, who had understood her to mean that she had been raped, and he had therefore reported the matter to the police.

When the police arrived, she - according to her explanation in court - had not been properly told of the rape accusation, but instead maintained the explanation about the rape.

- But when the police reviewed the evidence - including a video surveillance - they were able to ascertain that her explanation about the rape was not correct, and she also confessed to the false report, explains prosecutor Lotte Nielsen, Nordjyllands Police.

The woman's age and an otherwise unblemished criminal record until this case contributed to the sentence being a 14-day suspended sentence. The 19-year-old woman received the sentence.
